4.	Frost Fayre:		
	JW confirmed that again there was a lot of interest shown in our Campaign and that donations were made totally £50 which has been paid into the account.		
5.	Crowd Funding:		
	This was the main subject for discussion within this meeting. PT had kindly produced a 'Main Checklist' which assisted in concentrating our minds on the important issues which needs to be agreed at this meeting.		

This covered the areas, of the Crowdfunding Project content; agreeing the appropriate Launch Date; Contacting the Press and other Media; including the different methods that we can use to ensure good publicity of this campaign.

- Contact to be made with Rodrey Clark (Western Mail)

- Contact to be made with MCC Press Officer FT to progress
- Local schools to be contacted with possible emails being sent by the children to their parents advising them of our Campaign for support – FT to progress Magor and KP to progress with Undy School
- RailUKForum PT to maintain contact and update them on our progress
- All Committee Members, where possible, should be using Twitter, Facebook and emails to spread the message around to gain support for the Campaign
- Posters to be created and circulated to the two main pubs in the square; Donnies and also the Local Community Boards. Poster should include the straplines – "Have You Pledged Yet" and "Your Community Needs You" – LT to progress
- Leaflets could also be produced and circulated at such places as the Farmers Market, Cake Saturday and Severn Tunnel Junction.

Confirmation was given that the Monmouthshire Transport and Strategy Group has moved our Campaign to Priority 4 out of a list of 27. It is very clear that this group is becoming well noticed as a group worth listening to.
