Outcomes by April 2018



- Excellent progress on delivery of the Walkway station, in combination with the community hub
- We are certain that we will achieve the aim of a station for Magor with Undy
- Residents understand that MAGOR is working to deliver a station and an associated community hub
- Welsh Government demonstrates support for the community led initiative
- The press and media continue to be interested in our progress
- The GRIP 3 process is fully funded and has been completed
- The GRIP 4 process has been commissioned
- People are still very supportive of MAGOR and its campaign for a new station and improved rail services
